Robert (Bob) Scholl



MESSAGE FROM MEMBER SERVICES: Director nomination details

As we begin to prepare for Mor-Gran-Sou Electric Cooperative's annual meeting on June 11, we have begun to seek director nominations. Our board of directors leads our cooperative with passion and forward thinking to ensure the longevity of Mor-Gran-Sou Electric. If you are interested in running for a director position, learn more below!

Director elections

The initial commitment is a three-year term, with provisions in the bylaws limiting a director to serving six consecutive three-year terms, after which time the director is not eligible for another six consecutive three-year terms until one year has elapsed.

At the annual meeting on June 11, the following three board positions will be elected:

- **Grant County** – currently held by Casey Wells (serving his sixth and final three-year term)
- **Mandan Area** – currently held by Robert Leingang (serving his sixth and final three-year term)
- **Sioux County** – currently held by Rodney Froelich (serving his second three-year term)

Under the bylaws and due to a mail-in ballot, no nominations are accepted from the floor at the annual meeting. Instead, the bylaws require the board of directors to appoint a Nominating Committee of five to nine members who geographically represent the cooperative. These members will provide a list of qualified and willing candidates to the board for approval and inclusion on the ballot at the board of directors' meeting scheduled for Feb. 25. This date has been set so there is adequate time for each candidate's biographical information to be included with the notice of meeting sent to the members in May, along with the mail-in ballot for those who are unable to attend the annual meeting in person.

Nominating Committee

The Nominating Committee, which is appointed by Mor-Gran-Sou Electric's directors, met for the first time Dec. 15, 2025. The committee will meet for a final time at 6:30 p.m. CT on Feb. 19.

For a person to be nominated, the member running for a board seat must submit the completed

declaration of candidacy form to Mor-Gran-Sou Electric by 4 p.m. CT on Feb. 12. All qualified and willing candidates who have completed and forwarded the written declaration of candidacy form to the Mor-Gran-Sou Electric office by the Feb. 12 deadline will be included in the list the Nominating Committee will provide to the board.

Bylaws and resolutions

Under the bylaws, any bylaw amendments or resolutions must be presented to the members in writing in advance of the annual meeting scheduled for June 11. The board of directors has charged the Nominating Committee with reviewing and advising the board of any proposed bylaw amendments and resolutions. Therefore, any proposed bylaw amendments and resolutions should be submitted in writing no later than Feb. 12 and/or they can be presented in person at one of the Nominating Committee meetings.

MESSAGE FROM OPERATIONS:

Navigating rising infrastructure costs

The past five years have been a period of rising costs for everyone, including the electric utility industry. Increased costs are a result of soaring demand for electricity, supply chain challenges, material shortages and increased labor costs. The impact beyond increased infrastructure costs includes more unpredictable timelines.

Mor-Gran-Sou Electric Cooperative uses a multi-year work plan, which allows for ample time to order and

secure materials for upcoming projects. Along with cooperatives across the country, Mor-Gran-Sou Electric has not been excluded from the supply chain and material challenges. For instance, the cost of transformers and regulators has doubled in the last five years and lead time to secure them continues to change. Uncertainty in the supply chain causes the operations team to step back and reevaluate projects to

ensure time and money are efficiently utilized.

Impacts can be seen all the way down to equipment and materials used by crews every day. Bucket trucks and digger derrick trucks have seen price increases of \$35,000 to \$40,000, and lead time for ordering has increased. The price tag on utility poles has increased by \$300 over the last five years. Underground cable and wire prices have fluctuated over the years and lead times are expected to be six to seven months.

Due to the increase in price and lead times, we know it is important to plan and adapt to changes. Thankfully, we have an effective team of operations personnel and engineers who work efficiently to ensure co-op projects continue, so we can deliver reliable electric services to our members.



We understand prices for essentially everything are rising, and that puts a strain on everyone. As Mor-Gran-Sou Electric navigates rising industry costs, we work closely with our CEO\Co-General Managers and board of directors to explore ways to manage costs for you, our members, while ensuring the reliability of your electric service. 

Infrastructure Costs

Utility poles (wood, steel, composite)	+25-40%
Crossarms & braces (steel/wood)	+20-35%
Conductor wire (aluminum/copper)	+30-50%
Transformers	+70-100%
Grain-oriented electrical steel	+80-100%
Circuit breakers/reclosers	+20-35%

Fleet Costs

Light trucks	+25-40%
Bucket trucks, digger derricks	+20-50%
Fuel costs (especially diesel)	+20-30%
Maintenance	+15-25%

SAFETY STARTS WITH ME: Snow removal around electrical equipment

Winter is here. As wind, snow and ice conditions continue, members break out their shovels and snowblowers once again. While removing snow and ice, it is important to keep any electrical equipment Mor-Gran-Sou Electric Cooperative may have on or near your property in mind.

Equipment, such as meters, pad-mounted transformers, commonly known as the big green box, or even overhead lines, are typically located

near snow removal sites such as homes, shops and businesses.

"Keeping areas like your meter and pad-mounted transformers on your property clear of snow and ice helps us act quicker in the event of an outage," says Doug Roethlisberger, a journeyman lineworker. "But it is important to do so safely."

Here are a few tips to keep in mind this winter as you remove snow:

- **Locate electrical equipment:** Before a heavy snowfall, mark the location of electrical equipment with flags to easily see it when removing snow.
- **Be gentle when clearing snow:** Always use a shovel to clear snow around electrical equipment. Never use a snowblower or plow directly against it.
- **Maintain clearance:** Ensure a safe distance is carefully cleared around pad-mounted transformers, which is typically at least 10 feet in front and 3 feet on the sides.
- **Be aware of overhead lines:** Be mindful of overhead power lines, especially when removing snow from roofs. Never attempt to remove ice from power lines.
- **Report damage:** If you notice any damage to electrical equipment due to snow removal, contact our office as soon as possible. Do not try and fix the damage yourself.

Keeping these tips in mind will help Mor-Gran-Sou Electric ensure safe and reliable electrical services continue to power your homes and businesses. Please remember, if you notice any damage to electrical equipment, contact our office as soon as possible at 800-750-8212.

The board of directors meeting of Mor-Gran-Sou Electric Cooperative was held on Nov. 19, 2025, at the Mandan Service Center. Chair Steve Tomac called the meeting to order at 12:30 p.m. A quorum was present. Also present were Mor-Gran-Sou Electric co-General Managers/CEOs Jason Bentz and Travis Kupper, Chief Financial Officer Alex Craigmile, Manager of Operations Gary Fitterer, Chief of Staff/Member Services Manager Julie Armijo, Interim General Counsel Andrew Fergel and Administrative Assistant Samantha Fischer.

Consent agenda: The consent agenda was approved as presented.

Strategic items: Bentz and Kupper presented the co-general managers' report, which included updates on Basin Electric Power Cooperative, Western Area Power Administration and other items. Several additional Basin Electric reports and board documents were available for review.

Action items: Action items were discussed and resolved.


Discussion/general information: The board discussed the preliminary operating budget, bylaw amendments and other items.
