### Idle services to be retired

Mor-Gran-Sou Electric Cooperative continues to retire idle services that are not making any payment to the cooperative, but continue to receive regular maintenance. Our procedure is to post a detailed list in our communications material to keep members informed of idle services that will be retired. This is the first notice of this particular group of idle services to be retired.

Co-op personnel have already contacted, or tried to contact, the property owner and affected property owners based on the information available. If someone is willing to pay the line retention fee, we no longer consider it an idle service. If no one comes forward, the line is put on a list and will be retired.
